Alex Blum is Professor Emeritus of Philosophy at Bar-Ilan University, Israel. He founded, with Asa Kasher, the journal *Philosophia* which they co-edited during its first five years of its existence. He wrote two logic texts which were published in Hebrew covering much of elementary logic and published over 70 papers and pieces in philosophical journals. Among them: *Analysis*, *British Journal of the Philosophy of Science*, *Dialectica*, *Philosophical Studies*, *Nous*, *Notre Dame Journal of the Philosophy of Science*, *Skepsis*, *Philosophical Investigations*, *Organon F*, *The Journal of Value Inquiry*, *Logique et Analyse*, and *Iyyun*.
